The conference highlighted nimble and effective ways of working collaboratively with a variety of partners, and we hope to emulate these successful models in our work going forward.



# **WORKING FOR ONTARIO MUSEUMS**

#### PROVINCIAL AND FEDERAL BUDGET SUBMISSIONS

The OMA brought forward budget recommendations to both the Provincial and Federal governments. OMA Council and ED also presented to Ontario's Standing Committee on Finance and Economic Affairs.

Recommendations submitted in 2019 for the 2020 Budget were:

- A. Create Jobs for Young People in Growing Sectors and
- B. Develop Digital Access & Engagement for Rural Communities.

These recommendations were precursors to submissions made as part of Ontario's COVID-19 recovery budget; An Ontario Museums Relief Fund, A Digital Response Fund, and long-awaited review and increased funding for museum programs. Budget submissions identified the contributions that Ontario's museums make to their communities through education, economic development, and employment.

#### BILL 108- MORE HOMES, MORE CHOICE ACT, 2019

Bill 108 proposed many changes for Ontario in July 2019. The OMA shared materials from our fellow Provincial Heritage Organizations the Architecture Conservancy of Ontario and Community Heritage Ontario. OMA amplified members' concerns for conservation authorities about support for conservation authorities and their contributions to local communities. contained in Bill 108 through letters to the Honourable Jeff Yurek, Minister of Environment, Conservation and Parks. OMA President Paul Robertson joined a committee advocating for the value of the R. Tait Mckenzie Memorial Museum to ensure the collection and appropriate considerations were made.

#### REGIONAL GOVERNMENT REVIEW

OMA Council participated in a consultation for Ontario's Regional Government Review, highlighting the need to consider the museums as a part of any changes to municipal governance. In Ontario, municipalities contribute 84% of government funding for smaller and mid-size museums. The OMA's participation also emphasized the need for community consultation to determine what residents and tourists want and need from their museums.

#### MODERNIZING COMMUNITY MUSEUM FUNDING WORKING GROUP

The Modernizing Community Museum Funding Working Group of OMA Council sought out data sources to develop an evidence-based model for presentation to government. Using data from the OMA's Ontario's Museums 2014 Profile and the Museum Impact Survey, supplemented with partial data from the Community Museum Operating Grant Program (CMOG) and the Government of Canada Survey of Heritage Institutions, the Working Group compared elements and levels of funding in other programs and jurisdictions to develop recommendations for sustainable operating funding.

#### NATIONAL, PROVINCIAL, AND TERRITORIAL MUSEUM ASSOCIATIONS (NPTMAs)

Through collaborating with partners the Canadian Museums Association and Associations at the provincial and territorial level, the OMA contributed to the following advocacy initiatives:

- Joint letters to party leaders in advance of the 2019 Federal Election, asking specifically about support for museums
- $\bullet$  A meeting with Minister Guilbeault held at the ROM in January 2020
- Continued advocacy for the New National Museums Policy, especially after its inclusion in Minister Guilbeault's mandate letter

### MAY IS MUSEUM MONTH / MAI, MOIS, DES MUSÉES 2019

2019 presented an opportunity to expand May is Museum Month / Mai, Mois des Musées through connected and digital initiatives. The OMA engaged Ontario-based travel writers to visit museums in the province and profile them in their web publications. The OMA also solicited statements from Her Honour the Honourable Elizabeth Dowdeswell, Lieutenant-Governor of Ontario and then-Minister of Tourim, Culture and Sport Michael Tibollo.

#### Other digital tools developed:

- Template letters and requests for municipalities to proclaim May is Museum Month in their communities
- Social Media graphics
- Analytics research to measure the impact of the month

#### **Results:**

- Statement for International Museum Day from Lieutenant-Governor Elizabeth Dowdeswell
- Statement in the Legislature by then-Minister Tibollo recognizing May is Museum Month, with responses by NDP Culture Critic Jill Andrew and Liberal MPP Mitzie Hunter
- 14 municipalities proclaimed May is Museum Month in 2019
- 2.4 million+ impressions and social media engagements with the public

# NEW MUSEUM NETWORK: PETERBOROUGH KAWARTHA LAKES MUSEUM NETWORK (PKMN)

With the leadership of Joe Corrigan of OMA Council, the OMA assisted in the connecting and coordinating of a new museum network for Ontario. The Peterborough Kawartha Lakes Museum Network (PKMN) joins the nearly two-dozen other networks that strengthen connections among museums and the OMA.

#### PRIORITY SETTING AT CONFERENCE 2019

At the OMA Annual Conference 2019 in Brantford, OMA Council Member Cheryl Blackman led RMN representatives in a "dot-mocracy" exercise to develop and set the priorities for the RMN Steering Committee. The Committee's Priorities are:

- 1. Sustainable operating funding (for Networks and member sites)
- 2. Succession planning
- 3. Support for active internships—especially rural and Northern museums
- 4. Promotion for sites

The RMN Steering committee will work with the OMA and other groups to move these priorities forward.

Regional Museum Network representatives also heard a presentation from the OMA Council Member Michael Rikley-Lancaster of the work of the Modernizing Community Museum Funding Working Group and the results of the Museum Impact Survey, which was developed and promoted through connections between the OMA and the RMNs.

# **TOWARDS INCLUSION 2025**

#### OMA AT THE ASSOCIATION OF AFRICAN AMERICAN MUSEUMS CONFERENCE

In this session during the 2019 OMA Annual Conference, Ontario delegates who had the opportunity to attend the 2019 Association of African American Museums annual conference in Mississippi shared their experiences and what they learned. They highlighted the benefits of Ontario museums participating in Black and African museum networks. The delegates also outlined how the employment of Black museology is integral to a more critical interpretation of the diversity and complexities of Black Canadian and African diasporic experiences, including the realities of anti-Black racism, past and present. The presenters discussed how their learning and experiences will inform their future work at their respective institutions and organizations through the exploration of three case studies: the challenges of exhibiting the African collection held by the Art Gallery of Hamilton, the interpretation of the Oro African Church site, and the need for a Black history and cultural space located in Toronto.

#### WHAT WORKS IS NETWORKS: POWER TO CHANGE - MUSEUM DETOX

**Thanh Sinden** is an independent museum consultant, and Chair of the Museum Detox steering group, where she champions fair representation and inclusion of BAME cultural, intellectual and creative contributions of past and present. At the OMA Conference 2019, Thanh will shared some thoughts on the network's journey, where their impact has been, and where they continue to look to make change.

The Museum Detox Network is a collective of BAME (Black, Asian, and Minority Ethnic) museum workers founded in 2016 to effect a systemic challenge to the lack of diversity and audience representation in the museum sector. In 2019, Museum Detox continued to use a network model to enable a sector where diversity thrives, and a workforce and audience that is reflective of the UK's 21st century population.



#### INDIGENOUS MATTERS PANEL

In 2019, where do museums and other GLAM sector organizations find ourselves in our work toward reconciliation and decolonization of our practices? The Indigenous Matters panel discussed current initiatives, from official responses to the TRC Calls to Action, to cross-disciplinary grass-roots organizing, to local and international projects.
